Official complaint

The IFAGG Council decided on 500 € refundable deposit money for official complaint to Ethical Committee or Council. The official complain can be done only by the official IFAGG member. If the complaint is proved to be justifiable, the money will be refunded.

Keeping the judges license 2022

Keep the license for 2022 (without raising the level)

- Judge in min. 1 B-category competition

or

- Participate in Judge course

Exception: In case judges are from own country with restrictions (not allowed to travel for some reason - Covid restrictions, War situation or other force majeure situation), could participate in min. 1 online competition (judging the whole competition).

IFAGG fees 2022

Here you have all the fees concerning competitions and judges' courses and webinars.

Participation fees 2022 (paid to LOC)

A-category competitions (World Cups, Challenge Cups and another A-cat. competitions):

- Team consists of 1-6 gymnasts + max. 2 coaches: 150€/team
- Team consists of 7 – or more gymnasts + max 3 coaches: 180€/team

World Championships and IFAGG Trophy:

- Team consists of 1-6 gymnasts + max. 2 coaches: 250€/team
- Team consists of 7 – or more gymnasts + max 3 coaches: 300€/team

B-category competitions:

- Team consists of 1-6 gymnasts + max. 2 coaches: 100€/team
- Team consists of 7 – or more gymnasts + max 3 coaches: 130€/team

These fees are same for junior and senior teams and for all age categories in B-category competitions.

Judges' courses and webinars 2022 (paid to IFAGG)

Judges' course with exam

- For member 300€/participant
- For not members 350€/participant

Judges' course without exam

- For member 200€/participant
- For not members 250€/participant

Webinars

- For member 40€/participant
- For not member 60€/participant

Organizing fees for IFAGG Competitions 2022 (paid to IFAGG)

By the decision of the IFAGG Council, organizing fees for the IFAGG Live A- and B-category competitions for the year 2022 are -50% of the price.

IFAGG World Championships

- ~~4000€~~ **2000€** women + junior

IFAGG Continental Championships

- ~~2000€~~ **1000€** women + junior

IFAGG World Cup

- ~~1300€~~ **650€**

IFAGG Trophy, other A-category competitions

- ~~1000€~~ **500€** women + junior

IFAGG Challenge Cup

- ~~700€~~ **350€**

IFAGG B-category competitions

- ~~500€~~ **250€** all age categories

IFAGG Online-competitions

- **100€** all age categories

Registration document of your national organization

IFAGG is asking all the members who still haven't send an official registration document of the national federation or club, to send it at the latest 15th of April. This is needed because IFAGG is willing to develop AGG and needs all the information about the members and their organizations.

We would also like remind about the judges' info. Some members haven't sent it yet.

General Data Protection Regulation (GDPR)

The General Data Protection Regulation is a regulation on EU data protection. The aim of GDPR is to protect individuals control and rights over their personal data. This means that we are not allowed to share anyone's personal data like mail addresses to other people.
